## Stakeholder feedback from NAPA All-Party Workshop

5 December 2024, London

## Comments from online attendees in meeting chat:

"Really great day with so much interesting discussions - well done to all and apologies again to not make it in person - its been a really amazing session."

"Thanks to all. I think this has been a very useful session and great inputs."

"One potential area to look at going forward is whether NAPA could develop and then release a few scenarios of what an agreement resolution for each of the species might look like. All the coastal states say they are keen to reach an agreement, so even if they disagree with any of the proposals it might help with "well if not this allocation/resolution what would you be proposing and why?""

Always challenging to pitch your input at the right level so hope my challenge landed well for everyone

I look forward to what's next and a massive well done for getting all those parties in the room today, a really powerful meeting and one which was good for the CS to acknowledge would be very beneficial in the future, so maybe we could plan another one in 2025.

Also just picking up on NAPA's current asks, I wonder if we are making it too complicated in asking CS to reduce catch in international waters and that dilutes our main ask which is - all agree to follow the advice, don't overfish, allocate fairly and stick to it and then manage the stock effectively.

I raise this as I thought Kate from Faroes was very good today and if she doesn't believe the reduce fishing in international waters is worth focusing on then maybe we should reconsider our asks!"

## "Good morning Aoife, Fi

Just a brief mail following up the meetings yesterday in London to express sincere thanks to you and the team.

The NAPA event was extremely well coordinated /hosted with very high quality attendance (particularly with respect to securing representatives from Science / Catching Sector and Coastal States).

It was clear to see that the level of shared knowledge and understanding around the issues increased significantly through this format and the welcome opportunity to have frank dialogue particularly with those with experience of negotiating coastal states agreements.

Thank you also for your time in recent weeks to listen and take on board our advocacy suggestions as direct action requests.

It was extremely useful to set out the merits of the 10% Banking and 10% High Seas caps as reasonable management principles for Costal states to associate with and put the ball in their court......

The issue of fishing on the High Seas targeting mackerel for Fishmeal/Oil remains a challenging issue.

We know the aquaculture feed market is a consolidated and powerful sector and Marin Trust plants already identify for audit purposes Mackerel from trimmings sources.

From conversations around the margins yesterday I sense a strong reluctance of some of the NAPA membership to even discuss this matter.

Bottom line, so long as NAPA members continue to provide a market in the feed sector for Whole Mackerel there will be "no cost associated with not having a Coastal States agreement" - something Esben pointed to clearly.

As a % component Mackerel is probably circa 1% of the total feed volumes of some NAPA members so it can be easy to overlook the importance of this issue.

Given NAPA has made two significant requests of the CS Negotiators - it would seem sensible that NAPA members should also look to what is within NAPA's gift to enact change- - I would suggests its appropriate for NAPA feed / fishmeal interests to adopt a sourcing commitment "ONLY to purchase Mackerel from trimmings " or something similar......
