Please recall the tele discussion today we had on the above subject and our earlier requests. As you are aware M/s Omega Fishmeal & Oil Pvt. Ltd Ratnagiri is one of the leading exporters of fishmeal & fish oil from the country. We also supply fishmeal to major aquaculture feed manufactures in India for the production of fish/shrimp feeds. The major raw material what we used for the production are Indian oil sardine & Indian mackerel caught from the waters of Maharashtra and Goa.

In order to promote the export/sale of our products abroad and in India, we commenced the "Fishery Improvement Project" (FIP) for Indian oil sardine and Indian mackerel along the coastal waters of Maharashtra, & Goa in 2017. The project's main focus is to improve the living conditions and efficiency of fishermen, better fisheries management and governance together with environmental responsibility and transparent traceability of fishery products throughout the supply chain.

This is the first fishmeal plant in India getting such approval. - 1. Provide clarity for all those involved in the fishery (including those that depend on the catch) about the objectives, rules/regulations, catch sharing arrangements and sustainability measures all work together.
- 2. Provide opportunities for stakeholders to be involved in the decision making process. Increasing transparency helps build support amongst interested parties as well as accountability.
- 3. Ensure that information collection is focused on supporting management and those that depend on the fishery.
- 4. Provide certainty and investment confidence for the post-harvest sector if sustainable use is achieved
