

# GAP ANALYSIS REPORT ON ENFORCEMENT TOOLS IN KARNATAKA STATE FISHERIES

#### 1. Introduction

The Department of Fisheries, Government of Karnataka, has prioritized the sustainable management of fisheries through strict enforcement of regulations and robust monitoring of Illegal, Unreported, and Unregulated (IUU) fishing. A specialized Task Force team, in collaboration with the Coastal Police, has been established to ensure effective surveillance and compliance. This report evaluates the enforcement tools and mechanisms in place and confirms the absence of enforcement gaps.

## 2. Enforcement Tools in Place

## 2.1 Task Force Operations

- A dedicated Task Force team has been constituted for IUU fisheries monitoring.
- The team is supported by the Coastal Police for legal enforcement and on-ground/sea operational backing.
- Routine landing center-based inspections are carried out to check compliance with fisheries regulations.
- At-sea inspections are conducted with the support of commercial fishing boats to identify and intercept violators in real time.

#### 2.2 Penal Actions

- Multiple penalties have been imposed on fishing vessels found in violation of IUU regulations.
- Enforcement actions have created strong deterrence against illegal operations.
- Uniform enforcement ensures fairness and transparency across all fishing fleets.

#### 2.3 Vessel Tracking Systems

 All fishing vessels have been equipped with transponders for continuous monitoring of movement and fishing activity.

- Enforcement Capacity: The Task Force and Coastal Police coordination provides strong operational coverage both at sea and at landing centers.
- Penalty and Compliance Framework: Strict penalization of violators has strengthened deterrence.
- Capacity Building: Fishermen are trained and cooperative, enhancing compliance rates.
- **Sustainability and Transparency:** Implementation has been systematic, with continuous improvements already incorporated.

#### 4. Improvements Effectively Implemented

- Full transponder installation across the fishing fleet.
- Regularized monitoring with a combination of sea patrols and shore inspections.
