Assessment Determination
<p>If a species is categorised as Endangered or Critically Endangered on IUCN’s Red List, or if it appears in the CITES appendices, it cannot be approved for use as IFFO RS raw material.</p> <p>Albacore Tuna (<i>Thunnus alalunga</i>) is listed on the IUCN Red List as globally Near Threatened (NT) and Least Concern (LC) in Europe and is not listed in CITES such that albacore derived products are eligible for approval for use as IFFO RS by-product raw material.</p> <p>On the basis of available information, the existence of three Atlantic albacore stocks are assumed: northern and southern Atlantic stocks (separated at 5°N) and a Mediterranean stock. Given that FAO 34 Atlantic, Eastern Central straddles 5° N latitude, the northern and southern Atlantic stocks are included in this assessment.</p> <p>Fishery removals of the stock are considered in the stock assessment processes so the stock PASSES Clause C1.1.</p> <p>As of the latest assessment of stock status biomass is considered to be above the corresponding limit reference such that the stock PASSES Clause C1.2.</p> <p>As the stock passes both Clause C1.1 and C1.2, the by-product covered by this report is APPROVED for the production of fishmeal and fish oil under the current IFFO RS v 2.0 by-product standard.</p>
Peer Review Comments
<p>The assessor correctly classified the Southern and Northern Atlantic albacore tuna as category C species as both stocks are subject to specific management regime. Stocks are assessed and stocks status is assessed relative to reference points.</p> <p>Fisheries removals are considered in stocks assessment. According to the last stock assessment, the bioboth the Southern and the Northern albacore tuna stocks biomass is considered to be above the limit reference point.</p> <p>Therefore, the peer reviewer agrees with the assessor’s determination that the fishery passes both C1.1 and C1.2.</p>

<p>Therefore, fishery removals of the species in the fishery under assessment are included in the stock assessment process and the fishery PASSES clause C1.1</p>

<p>The current status estimates for Atlantic albacore stocks is based on analysis conducted in July 2020 using data to 2018.</p>																																																						
Northern Atlantic albacore																																																						
<p>Model results suggest a biomass drop between 1930 and the 1990s and a recovery since concurrent with decreases in fishing mortality. The stock was estimated to have been slightly overfished with $B < B_{MSY}$ in the period late-1970s – 2000s, but has now recovered to levels well above B_{MSY} such that $B_{current}/B_{MSY} = 1.32$ with 80% Confidence Intervals of 1.13 – 1.51.</p>																																																						
<p>With respect to the status of the stock with respect to its limit reference point (or proxy), $B_{2019}/B_{LIM} = 3.30$ with 80% Confidence Intervals of 2.83 – 3.78 such that the stock is considered, in its most recent stock assessment, to have a biomass above the limit reference point (or proxy) meaning; therefore, the stock achieves a PASS against C1.2.</p>																																																						

Southern Atlantic albacore

Model results suggest that biomass has increased since fishing mortality started to decrease in the early 2000s, and that there is currently a 99.4% probability that the South Atlantic albacore stock is neither overfished nor subject to overfishing. The stock is currently estimated at $B_{current}/B_{MSY} = 1.58$ with 95% Confidence Intervals of 1.14 – 2.05.

With respect to the status of the stock with respect to its limit reference point (or proxy), a limit reference point is not defined but with $B_{current}$ comfortably above B_{MSY} the stock can be considered, in its most recent stock assessment, to have a biomass above any limit reference point (or proxy); therefore, **the stock achieves a PASS against C1.2.**

SOCIAL CRITERION

In addition to the scored criteria listed above, applicants must commit to ensuring that vessels operating in the fishery adhere to internationally recognised guidance on human rights. They must also commit to ensuring there is no use of enforced or unpaid labour in the fleet(s) operating upon the resource.

Appendix B: From MARINTRUST Standard V2.0 Annex 2: Fish By-product Assessment Methodology

Definition of a Fish By-product

A by-product is a useful and marketable product that is not the primary product being produced. A marketable by-product is from a process that can technically not be avoided. This includes materials that may be traditionally defined as waste such as industrial scrap that is subsequently used as a raw material in a different manufacturing process.

"Fish By-products" refers to commodities that are manufactured from fish, including shellfish, and crustaceans in a form that is different than conventional foods and which are intended for human consumption (either directly or as a food ingredient). Fish By-products include, but are not limited to:

- By-products derived from fish, including fish cartilage, fish oils, and fish proteins; and
- By-products derived from the carapaces of crustaceans; but do not include marine plants or marine plant products.

(Canadian Food Inspection Agency Definition)

In addition, a whole fish which is rejected on an intrinsic quality ground e.g. does not meet the specification for human consumption due to physical damage or the quality is substandard. These whole fish shall in these cases be classified as a by-product from the human consumption fishery, and can be used for marine ingredients production.

A whole catch of fish that is rejected by a fish processing factory on economic grounds is not considered to be a fish by-product. This fish can only be used for marine ingredients production if the fishery has been assessed and approved under the requirements of the IFFO Responsible Sourcing Standard.

Why utilise Fish By-products?

FAO Code of Conduct for Responsible Fisheries

General Principles Article 6

6.7 The harvesting, handling, processing and distribution of fish and fishery products should be carried out in a manner which will maintain the nutritional value, quality and safety of the products, reduce waste and minimize negative impacts on the environment.

Responsible fish utilisation Article 11.1

11.1.8 States should encourage those involved in fish processing, distribution and marketing to reduce post-harvest losses and waste.

Benefits of Including Fish By-Products in the MARINTRUST Standard:

1. Improved fish resource utilisation
2. Reduction in waste for nutritional value
3. 35% of fish by-products are currently used to make quality fishmeal and oil

5. Better compliance with FAO Code of Conduct for Responsible Fisheries

What Fish By-products cannot be used?

1. IUCN

Fishery By-products shall Not be taken from a species listed by IUCN (the International Union for Conservation of Nature) under the Red List for certain categories;

- EXTINCT (E) AND EXTINCT IN THE WILD (EW)

- CRITICALLY ENDANGERED (CR) facing an extremely high risk of extinction in the wild.
- ENDANGERED (EN) facing a very high risk of extinction in the wild.

Fish By-product material may be used from the vulnerable category, but it shall incur a fishery surveillance conducted by the certification body prior to it being included in the scope of this standard.

- VULNERABLE (VU) facing a high risk of extinction in the wild.

The Fish By-product material from these species will be acceptable for use in the scope of this standard;

- NEAR THREATENED (NT) does not qualify for above now, but is close or is likely to qualify for, a threatened category in the near future.
- LEAST CONCERN (LC) Widespread and abundant.

Fish By-product material may be used from the following category, but it shall incur a fishery surveillance prior to it being included in the scope of this standard;

- DATA DEFICIENT (DD) and NOT EVALUATED (NE)

The fishery surveillance conducted by the certification body will review the following areas:

Stock Assessment

- From a recognised Institution
- Fisheries are recognised as legal
- Fisheries do not contradict scientific opinion

2. FAO Code of Conduct for Responsible Fisheries

In addition the Fish By-products shall not come from fisheries that do not comply with the following criteria;

1. Fisheries should prohibit dynamiting, poisoning and other comparable destructive fishing practices.
2. Fishery material shall not be from IUU fishing activity nor sourced from vessels officially listed as engaging in illegal, unreported and unregulated (IUU) fishing activity.
