#### **Assessment Determination**

If any species is categorised as Endangered or Critically Endangered on IUCN's Red List, or if it appears in the CITES appendices, it cannot be approved for use as Marin trust raw material. European sardine (*Sardina pilchardus*) has been categorised by the IUCN as a species of Least Concern, and it does not appear in the CITES appendices. Therefore, European sardine is eligible for approval for use as Marin trust by-product raw material.

European sardine in FAO 27, ICES Divisions 8a,b,d is managed relative to established target and limit reference points using TACs, and was therefore assessed under Category C.

The stock was most recently subjected to a stock assessment in 2023, using international catch and survey data and applying the assumption that discards and bycatch are negligible. The assessment concluded that stock biomass is currently between the target and limit reference point levels. C1.1 and C1.2 are met.

Therefore, European sardine (*Sardina pilchardus*) in FAO 27, ICES Divisions 8a,b,d is **APPROVED** for the production of fishmeal and fish oil under the current MarinTrust v2.3 by-products.

#### **Fishery Assessment Peer Review Comments**

The assessor correctly classified European pilchard (*Sardina pilchardus*) in FAO 27, ICES Divisions 8a,b,d (Bay of Biscay) under Category C, the stock is subject to a specific management regime and reference points are defined.

Fishery removals are considered in the stock assessment process and the most recent stock assessment shows that the stock is above limit reference point. Therefore, the stock is considered to satisfy C1.1. and C1.2.

In conclusion, European pilchard (*Sardina pilchardus*) in FAO 27, ICES Divisions 8a,b,d (Bay of Biscay) passes both clauses (C1.1 and C1.2) and therefore should be approved under the MarinTrust Standard v2.3.

## **Species Categorisation**

**NB:** If any species is categorised as Endangered or Critically Endangered on the IUCN Red List, or if it appears in CITES Appendix 1, it **cannot** be approved for use as an MarinTrust raw material.

#### **IUCN Red list Category**

By-product material from a species listed by IUCN (the International Union for Conservation of Nature) under the Red List for the following categories shall immediately fail the assessment;

- EXTINCT (E) AND EXTINCT IN THE WILD (EW)
- CRITICALLY ENDANGERED (CR) facing an extremely high risk of extinction in the wild.
- ENDANGERED (EN) facing a very high risk of extinction in the wild.

By-product material may be used from the following categories provided that all clauses in the MarinTrust standard are passed.

- VULNERABLE (VU) facing a high risk of extinction in the wild.
- NEAR THREATENED (NT) does not qualify for above now, but is close or is likely to qualify for, a threatened category in the near future.
- LEAST CONCERN (LC) Widespread and abundant.
- DATA DEFICIENT (DD) and NOT EVALUATED (NE)

#### **CATEGORY C SPECIES**

In a by-product assessment, Category C species are those which are subject to a species-specific management regime and are usually targeted species in fisheries for human consumption.

Clause C1 should be completed for each Category C species. If there are no Category C species in the fishery under assessment, this section can be deleted. Where a species fails this Clause, it should be assessed as a Category D species instead.

C1.1 Fishery removals of the species in the fishery under assessment are included in the stock assessment process, OR are considered by scientific authorities to be negligible.

European sardine in ICES Divisions 8a,b,d is subjected to annual stock assessment by the ICES Working Group on Southern Horse Mackerel, Anchovy and Sardine (WGHANSA). The most recent assessment was conducted in 2023 and used an analytical stock synthesis model which incorporated catches in the model and the forecast. The assessment also included three survey indices and age composition data. Discarding and bycatch are considered negligible.

"ICES advises that when the MSY approach is applied, catches in 2024 should be no more than 19 811 tonnes." (ICES 2023)




Figure 1. European sardine in ICES Divisions 8a,b,d, catches (ICES 2023).

The catch advice does not raise any substantial issues with the robustness of the assessment. The stock is regularly subjected to a robust assessment. For catches, see Figure 1.

Therefore, fishery removals of the species in the fishery under assessment are included in the stock assessment process and therefore the stock PASSES clause C1.1.



C1.2 The species is considered, in its most recent stock assessment, to have a biomass above the limit reference point (or proxy), OR removals by the fishery under assessment are considered by scientific authorities to be negligible.




Figure 2. Sardine in ICES Divisions 8a,b,d, estimated SSB relative to current reference points (ICES, 2023).

The current status of European sardine is indicated in the most recent ICES catch advice, published in December 2023. The target reference points MSY B<sub>trigger</sub> and B<sub>pa</sub> have been set at 78,700t. The limit reference point B<sub>lim</sub> has been set at 56,300t. The 2023 stock assessment included a short-term forecast putting estimated SSB in 2024 at 64,331t, above the limit reference level but below the target reference level. Additionally, the catch advice states that "spawning-stock size is below MSY B<sub>trigger</sub> and B<sub>pa</sub> and above B<sub>lim</sub>" (ICES 2023). Current stock size is estimated to be larger than the limit reference point level (See Figure 2).

Therefore, the species is considered, in its most recent stock assessment, to have a biomass above the limit reference point (or proxy) and it PASSES clause C1.2.
